Missed Classes : Each child will be allowed **4 Make up Classes**; Parents must call and schedule make ups within the 16-week semester period. **NO REFUNDS FOR MISSED CLASSES.** **PROPER ATTIRE IS MANDATORY! Gym Pants, Shorts or Skirts (with leggings) and Tees. NO SHOES, SLIPPERS, CROCS, BOOTS/UGGS ALLOWED! No exceptions. To minimize distraction to instructors and children in class, WE DO NOT ALLOW parents/spectators to observe in the studio during class sessions. Drop off 5min before class and pick up at back entrance at the end of the hour.**
